

## Foundation Funds Historical Association Project

Renovations are under way at 522 Columbia St., the former Masonic Temple purchased in early 2017 by Tippecanoe County Historical Association.

The 13,200-square-foot building, slated to open in early 2018, will be a community center and museum. In the works: exhibit space, a banquet hall, dance floor, and, thanks to a grant from The Community Foundation, a soon-to-be-remodeled commercial kitchen.

## Discretionary Funds Meet Changing Needs

Change is the only constant, the adage claims, and “The Times They Are a-Changin’,” Bob Dylan sang 50 years ago. That is when our local population was less than half of today’s, Interstate 65 was yet to be completed, and before community needs prompted the launch of Lafayette Transitional Housing, Leadership Lafayette, Right Steps Child Development Centers, and numerous other nonprofits.

The point: Our community and its needs change, and we cannot predict how. That is why The Community Foundation of Greater Lafayette seeks and appreciates those who establish discretionary endowments, allowing grants to meet current needs.

### DONORS RECOGNIZE VALUE

Local donors Tom and Deb Parent are among those who chose the discretionary giving avenue. “We realize that the needs of our community are ever-evolving, and the pace of change seems to be accelerating,” Tom Parent says. “We want to enable The Foundation to be nimble in addressing community concerns, whatever they might be in the future.”

Tom and Mary Jo Sparrow also chose a discretionary endowment. “We appreciate education, the arts, work with children, and helping our friends in need,” Mary Jo Sparrow says. “We have witnessed changing needs, so we would rather let The Community Foundation decide what needs are more pressing in any particular year. We just don’t know what the future holds, so this allows flexibility.”

### KEEPING ALLOCATION OPTIONS OPEN

Currently, about 18 percent of The Foundation’s funds are discretionary. In 2016, more than \$342,500 from discretionary endowments went to 26 nonprofits, including Big Brothers Big Sisters of Greater Lafayette, Inc., Heartford House, and Willowstone Family Services.

“These funds address our community’s most pressing needs,” says Candy Silver, director of philanthropy. “As needs change, our board can respond most appropriately.”

Her gifts to The Foundation include a will bequest, charitable gift annuity, and an endowment for literacy, inspired by fellow elementary school students who struggled with reading because they could attend school only when it was their turn to wear the family shoes.

Giving and volunteering for The Community Foundation was “an easy call for me,” Nelson says. “It’s a working board, and I like that. I believe in the quality and integrity of the leadership, professionals who stay true to their mission, and they manage their money—our money—well.”

## Zest for Life Fills Nelson's Days

A love of people, a curious mind and an appreciation for a little fun describe her essence, says Betty M. Nelson. All three infuse her undertakings—from her Purdue University career to a retirement packed with volunteer service. To every endeavor, she takes focus, energy, efficiency, and respect for others.

“People are really important to me. They inspire me,” she says. As for curiosity, “It enriches life phenomenally. It causes me to see things and wonder.”

The fun side of life comes largely from enjoying what she’s involved in. “When I took the California Personality Inventory years ago, I registered a ‘1’ for play on a scale of ‘1-to-100,’ with ‘1’ being the lowest. I don’t vacation well,” she admits. “But work is play when I do what I enjoy.”

Yes, her pace sometimes reaches the hectic stage. When it does, nature and classical music prove calming.

### LOCAL RESIDENT SINCE 1965

Nelson’s zest for life began in Bluefield, W. Va., and was nurtured while earning a bachelor’s at Radford University and master’s at Ohio University. By the time she and her husband, Richard Nelson, pulled into West Lafayette in 1965, she was “more than ready” for a career.

She held several Purdue University student services posts, retiring in 1995 as dean of students emerita. Her appointment as United Way campaign campus chair kept her on staff a while longer.
