

The lessons they learned from athletic competition and leadership encouraged the family to set up a scholarship fund to reward leadership qualities like tenacity, enthusiasm, mentoring, hard work, time management, and pulling together a diverse group of individuals to achieve a common goal. The Truitt Family scholarship fills a niche by recognizing leadership on the court or field, regardless of whether students continue to play in college, knowing that these traits positively transfer later in life.

Libby Sheffield, Director of Counseling at West Lafayette High School, says "The scholarship allows them to recognize students who have excelled behind the scenes. Leadership shows in more places than just on the playing field, and this award is an acknowledgement of students who are well-rounded role models for their teammates."



Kathryn (Katie) Traynor, RN

Katie Traynor was a loving daughter and sister, spunky friend and girlfriend, and proud Boilermaker, starting her dream job as a neonatal intensive care nurse at **IU** Methodist Hospital. She had a passion for helping children and loved people and Purdue. Her



life was full. Four months after she graduated, at age 22, Katie died in a tragic boating accident at Dale Hollow Lake. The accident cut her life short just as it was getting launched. Her family established a nursing scholarship, in her memory, to help other nurses realize their dreams.

Emily Harrington, from Concordia, Kansas, was one of the 2020 recipients. Emily said, "This scholarship has helped me immensely in finishing my last year of nursing school. It meant the world to me that the committee saw qualities in me that resembled Ms. Traynor and felt I was deserving of this award. I am truly grateful."

Arlan Stavnhein

Originally a farm boy from north-central Iowa of 100-percent Norwegian descent, Arlan Stavnheim came to Indiana to pursue an industrial engineering career at Eli Lilly in 1963. He found a home in Lafayette just five years later. He retired in 1993, but he has never stopped working. Whether spearheading the Public School Foundation of Tippecanoe County, Tree Lafayette, or helping create Adopt-A-Spot or Adopt-A-Road programs in Lafayette, Arlan finds pleasure in identifying solutions for problems, acting on them, and moving on to the next big thing. He's a sparkplug in a think tank. The projects he tackles and the three endowments he established result from areas he recognized as needing attention and financial assistance.

Arlan established the Lafayette-West Lafayette Urban Forestry Endowment, which regularly supports Tree Lafayette, an organization of which Arlan was a founding member. Bill Arthur, Executive Director of Tree Lafayette, notes "Arlan and his wife can often be seen along our city streets helping prune and care for our trees. I cannot say enough how much we value their participation and appreciate their support."





Randy and Kathy Vernon

The Vernons are "boots on the ground" advocates for at-risk youth. Randy and Kathy support the Boys and Girls Club and fund Ivy Tech scholarships at Lafayette and Bloomington campuses. Recognizing that access to benefits and programing sets up children for success, regardless of their family's financial situation, motivated the Vernons to get involved. The beauty of their Community Foundation endowment is that it doesn't limit support to just one organization. Funding goes wherever it is most needed. As part of their planned giving, their endowment will continue to change lives for generations to come.

The Vernon's Field-of-Interest endowment supports at-risk youth. Last year, a grant went to Heartford House, an organization that advocates for youth who suffer from abuse or witness a crime in our community.
