Climbing to Greater Opportunities

In late 2024, The Community
Foundation of Greater Lafayette
received a Community
Leadership Implementation
Grant of \$7.061M from Lilly
Endowment Inc. through the
eighth phase of the Endowment's
Giving Indiana Funds for
Tomorrow (GIFT VIII)
statewide initiative. Through
GIFT VIII, Lilly Endowment
is supporting the efforts of

community foundations and their partners to strengthen quality of life for the people in the towns, cities, counties, and regions they serve.

Through this grant, The Foundation will strengthen its ties with community partners including the Greater Lafayette Career Academy (GLCA), Ivy Tech Community College – Greater Lafayette, and Right Steps Child Development Centers by developing a "Career Ladder" to support early childcare and education in Greater Lafayette.

The Career Ladder will primarily support childcare workers at various stages throughout their careers. Through the GLCA, high school students can pursue their Childcare Development (CDA) certificates while earning income. This apprenticeship prepares high school graduates to either immediately enter the workforce or continue their education in the field.

"GLCA is thrilled to offer a high school program that not only provides a crucial workforce development solution but also helps aspiring educators save on educational costs and time. The Early Childhood Education Apprenticeship also highlights the importance of collaboration with local community partners. By working together, we are ensuring a well-rounded, sustainable program that will provide long-term benefits for both apprentices and the families they serve," said Miranda Hutcheson, Director of Career and Technical Education at the Greater Lafayette Career Academy.

On the next step of the ladder, individuals may choose to pursue their associate's or bachelor's degrees in early childhood education through Ivy Tech or another institution. With Ivy Tech's partnership with Right Steps, students will be able to acquire practicum hours at a new Learning Lab and childcare facility, a project supported by this grant,

through faculty located at the center. Previously, earning practicum hours presented many logistical challenges, for Ivy Tech faculty and childcare centers to hurdle. With this center, students, faculty, and staff will have one central location to ensure practicum hours are met. This facility will also add over 150 new childcare spots in our community, and accommodate parents who work nontraditional hours.

This center will also be funded in partnership with the City of Lafayette thanks to the READI 2.0 program. Purdue University will provide additional funding for the center thanks to the Lilly Endowment Inc.'s Community College Collaborative initiative, which provided the University with a \$25M grant to incentivize integration between the school and the community with an emphasis on early childhood education.

Finally, in an effort to acknowledge that teacher retention is a large part of the current childcare shortage, this grant will support the development of a pilot program with Right Steps to incentivize longevity in childcare positions. New childcare workers will receive incentive bonuses at the 6-and 12-month marks of employment. Extensive research and program evaluation will be done in an effort to share its success more broadly to encourage additional support of our childcare workforce long-term.

This grant provides a welcome opportunity to make a small dent in the overwhelming need to support and reform our childcare landscape, which has been a focus

of The Foundation's community convening and leadership efforts over the last few years. Since 2022, David Lasater has been meeting with local community leaders to discuss and attempt to address the needs surrounding early childhood education and care. "One of the key roles of The Foundation is community convening and leadership. We are proud to support an important issue facing Greater Lafayette. Accessible, high-quality early education and childcare are essential for the well-being of children and families and play a pivotal part in driving economic growth by supporting workforce sustainability and expansion throughout Greater Lafayette," said David Lasater, The James Kirby Risk Endowed President and CEO of The Foundation.

More than Meets the Eye

In 2024, Bauer Family Resources received a \$10,000 grant to support the installation of an interactive mural at their location on 4th Street in Lafayette. But, as the project came to fruition, the project proved to be "so much more than just a capital project," according to Chief Executive Officer Tristen Kerwin.

The vision, according to artist America Carrillo, was to create a collaborative graffiti-style "art experience" that allowed the opportunity for individuals to work as a team to complete. Children who participate in Bauer's programs were able to work with Carrillo to contribute toward the mural's completion, enabling them to feel a sense of connection, pride, and collaboration with each other and the space.

Carrillo says that collaborative art experiences can transform a group by building confidence, providing an outlet for creative expression, foster skill development, encourage peer support, and provide team-building and problem-solving opportunities. The students were able to work toward a shared vision to accomplish the task and everyone played a special role. The mural now stands near the front entrance of the facility - a daily reminder of their contribution toward beautifying the building.

As someone who benefitted from the kinds of programs that Bauer has to offer as a kid – after school programs, meals,

homework help, parental resources - Carrillo felt a special connection to this project. And now, kids in our community feel pride and ownership over the building through the art they helped create.
